- You can opt-in to the two-pot system from 1 September 2024.
- When you choose to opt-in to the two-pot system, the Fund will create a savings component for you and a once-off amount of 10% of your
 retirement savings on 31 August 2024 or R30 000, whichever is the lowest, will be allocated to your new savings component at the end of the
 month in which you opt-in. This means if you opt-in to the two-pot system on 1 September, your once-off amount will only be allocated to your
 savings component on 30 September 2024. You can take the money in your savings component in cash once in a tax year if it is at least R2 000.
 The amount you take will be taxed at your marginal tax rate.
- The rest of your retirement savings will become your vested component. All rights, rules, and options will remain the same as they are on 1 September 2024, and you can still:
 - do a once-off full, or partial cash withdrawal of your vested component before retirement that will be taxed at the withdrawal lump sum tax tables.

- take your full remaining vested component as cash when you retire from the Fund and it will be taxed at the retirement lump sum tax table. Your opt-in election will be irreversible and you cannot change your choice later.
